SUBJECT

Public Education – Fall Reopening Update

REFERENCE

March 23, 2020	Idaho State Board of Education (Board) approved a soft closure of all public schools in Idaho through April 20, 2020.
April 6, 2020	Board extended the public school soft closure through the remainder of the academic school year with the option of an earlier entry under certain criteria. Additional action included recommendations to the Governor on statutory provision suspensions, and waiver of the number of hours of instruction that make up a semester credit.
April 16, 2020	Board approved re-entry criteria following the soft closure of schools due to the coronavirus pandemic.
May 4, 2020	Board approved minimum requirements for school districts and charter school to bring students back on campus after the soft closure.
July 9, 2020	Board approved Idaho's back to school framework.

APPLICABLE STATUTE, RULE, OR POLICY

Sections 33-116, and 33-512, Idaho Code

BACKGROUND/DISCUSSION

Following the soft closures of schools in the spring and the Board setting criteria for school districts and charter schools to resume in person instruction through the end of the 2019-2020 academic year, in April the Governor's K-12 Emergency Council asked that a working group be established to start planning for the fall and students' return to school. Two committees were formed: Public School Reopening Committee and Digital Divide Committee. Both committees convened in early June, and include Board members Critchfield, Clark and Liebich, legislators, Department of Education staff, school district and charter school administrators, operations staff, business and industry representatives and local health officials. President Critchfield chairs the Public Schools Reopening Committee. Board Secretary Liebich chairs the Digital Divide Committee. Due to the broad range of instructional and operational issues that needed to be covered, the committees then broke up into smaller groups that focused on each of these more specific areas and brought in additional subject matter experts to help with the more focused issues. The Public School Reopening Committee developed a framework for school districts and charter schools to use in planning for the 2020-2021 school year. This framework was established in a way that would help the schools plan in advance for operations based on three separate categories of disease transmission their local community might be experiencing at any one time. This advance planning would set expectations for students and parents as the

situation within their community rapidly changed and allow for the schools to pivot from and between each level of operations quickly.

The Idaho Back to School Framework identifies expectations, guidelines, and best practices to support local governance and a successful 2020-2021 school year, delivering on Idaho's constitutional obligation for a free, uniform, and thorough public education system during these extraordinary times. This framework is provided to help school districts and charter schools to plan in advance for varying levels of transmission of the Coronavirus within their local communities so that they can continue to provide quality instruction to all students throughout the year and students can grow and progress through the education continuum.

The framework clarifies the school districts' and charter schools' responsibility for developing their response plan and providing continued instruction, and the local health districts' responsibility in informing the schools on the category or level of transmission in their local community and serving in an advisory role to the schools in the development of their plans. The Board approved the framework on July 9, 2020.

In addition to the work being done by the K-12 public school system to prepare for the 2020-2021 academic year, Idaho's public postsecondary institutions have been equally hard at work developing plans to provide quality instruction to our postsecondary students in safe and effective manner in the midst of budget reduction and anticipated changes in student enrollment. Each of the eight public institutions will provide an update on the percent of courses that are currently scheduled to offered in-person; protocols for residential living (as applicable to the institution); and their COVID-19 testing plans and capacity (either on-campus or in collaboration with local health providers). Like the K-12 public school system, the postsecondary institutions are developing and adapting plans as the situation evolves.

STAFF COMMENTS AND RECOMMENDATIONS

Recommendations and areas of consideration outlined within the framework are based on recommendations from federal and state resources, Idaho education stakeholders, and local and national best practices. Some school districts and charter schools will not be able to address or implement all the strategies outlined in the framework due to their local resources and building infrastructure; and circumstances may dictate that some districts alter strategies as the health situation in their area changes. The considerations identified in the framework are not a mandate on how any school must respond, but a resource to be used. The

categories of transmission identified within the framework are those developed by the Department of Health and Welfare along with the local public health districts. This alignment allows for the local public health districts to identify the level of transmission in the community in which a school is located while the local board of trustees or charter school board of directors identifies how the school will respond. Local education agencies are responsible for providing instruction and other related educational services to all students during these difficult times, and they will need to use a variety of strategies to ensure all students have access to consistent learning opportunities, including students receiving special education services. In order to meet this responsibility, it is anticipated schools will need to use a blended learning approach to education as schools move up or down through the categories of community transmission or confirmed cases are identified within a school building. To meet these responsibilities, school districts and public charter schools are in the process of planning or implementing and adjusting plans that help them to meet their responsibilities for providing instruction to all students during the 2020-2021 academic year in a safe and healthy learning environment and a safe work environment for staff. Parents and guardians can expect their local public schools to provide a quality education that meets the state's minimum standards and prepares the students for their next level of education or to move into the workforce.

As the situations in a given community rapidly change, schools will be forced to adapt and update their plans to meet those changing conditions. The information provided today is based on the compilation of school district and charter school plans that were available over the past two weeks. While every effort is being made to keep this information updated, there may be some instances where a local board of trustees has met and adjusted their current planned mode of instruction or start date.

Based on current information all public schools in Idaho are expected to be providing instruction to their students by the end of the second week in September.

School districts and charter schools are listed based on the modality of instruction provided to the majority of their students. A school may be listed as on-line while still serving students receiving special education services or at-risk students in person in small groups or one-on-one while physically distancing. Schools indicating they are in-person four days a week and on-line one day a week are reported as in-person. Some school districts and charter schools are currently reported as in-person pending local Board action. All schools listed as providing in-person instruction are providing instruction with physical distancing and enhanced cleaning protocol.

Working with the Governor's Office, staff are working to develop a dashboard that can be updated weekly that will provide the Board a sense of what is happening in Idaho schools around the state. Due to the frequency of the changes in the more populated areas will only be able to give a snap shot in time of what is happening in a given week.

REFERENCE

March – April 2020	The Board has received weekly updates on the federal response to the coronavirus (COVID-19) pandemic and the availability of funding through the CARES Act.
April 27, 2020	The Board received an update on the allowable uses and amount of funds available to Idaho through the Elementary and Secondary School Emergency Relief Fund and Governor's Emergency Education Relief Fund.
May 4, 2020	The Board directed staff to move forward with data analysis for the discussed proposals and to identify sources of funds for those proposals.
June 10, 2020	The Board approved the use of the ESSER 10% SEA reserve funds for grants to local education agencies for devices, connectivity, infrastructure, adaptive technology, learning management system and PD around remote instruction and a request to the Coronavirus Financial Advisory Committee for \$30M that could be used for the same purpose.
July 15, 2020	The Board approved a methodology and grant application for \$30,000,000 from Idaho's relief funds through the Governor's Coronavirus Financial Advisory Committee

BACKGROUND/DISCUSSION

The CARES Act allowed the SEA to reserve up to 10 percent of the Elementary and Secondary School Emergency Relief (ESSER) Fund for grants to LEAs to be used for emergency needs as determined by the SEA to address issues responding to COVID-19. These funds must be awarded by May 18, 2021, and expended by September 30, 2022. At its July 15, 2020, meeting, the Board adopted the funding distributions, which included \$3.785 million for distance/blended learning with a priority for a Learning Management System (LMS). On August 14, 2020, the Department announced that five LMS providers had been selected as options for school districts needing an LMS: PowerSchool/Schoology, D2L, Instructure/Canvas, Its Learning and Otus. At the July 15 meeting, the Board also approved a methodology and grant application for \$30 million in funding from Idaho's relief funds through the Governor's Coronavirus Financial Advisory Committee to close the digital divide. A review committee was formed, which includes co-chairs Rep. Melissa Wintrow and Will Goodman, Board member David Hill, Rod Gramer with IBE, Terry Ryan with Bluum, Sherawn

Reberry with the West Ada School District, Peter McPherson, Chief Deputy at the SDE and Karen Seay, Federal Programs Director at the SDE. The soft deadline for grant application was Friday, August 14, 2020. An update will be provided on the status of both funding opportunities for blended learning.

IMPACT

This agenda item will provide the Board with an update on how the distribution of the ESSER SEA Reserve Funds are being implemented based on the Boards action at the July 15, 2020 Special Board.

STAFF COMMENTS AND RECOMMENDATIONS

The CARES Act establishes multiple funds dedicated to addressing impacts to education due to the 2019 Novel Coronavirus (COVID-19) pandemic, two of these funds provide allocations at the state level, while a third fund, the Higher Education Relief Act is disrupted directly to the postsecondary institutions. The Elementary and Secondary School Emergency Relief (ESSER) Fund allocates funds to the state education agencies based on the same proportion as states receive funds under Part A of Title I of the Elementary and Secondary Education Act in fiscal year 2019. Idaho's share of this fund is \$47,854,695. From this amount a minimum of \$43,069,226 (90%) must be distributed to the local education agencies (LEA) based on the LEA's proportional share of the state's Part A, Title I funds. These funds are distributed based on each LEA's propositional share of Part A, Title I funds received in 2019. Not all LEA's receive Part A, Title I funds. Part A, Title I funds are distributed based on an LEA's share of eligible Title I students. Up to 10 percent (10%) of these funds, \$4,785,470, may be reserved by the SEA "to be used for emergency needs as determined by the SEA to address issues responding to COVID-19."

Pursuant to the federal ESSER Fund Notice, SEA reserve funds may be used to award sub grants or enter into contract for emergency needs that address issues related to COVID-19. An SEA must ensure that an "LEA that receives an ESSER Fund sub-grant provides equitable services to students and teachers in non-public schools located within the LEA in the same manner as provided under section 1117 (Providing Equitable Services to Eligible Private School Children, Teachers, and Families) of the Elementary Secondary Education Act (ESEA), as determined through timely and meaningful consultation with representatives of non-public schools. In providing services or assistance to students and teachers in non-public schools, the LEA or another public agency must maintain control of the funds, and title to materials, equipment, and property purchased with such funds must be in a public agency." States have one year from date of the federal award to award the funds. ESSER Funds may only be used for elementary and secondary education relief.

At the June 10, 2020 Regular Board meeting the Board approved use of the ESSER 10% SEA reserve funds towards grants to local education agencies for funding for professional development to provide social emotional and behavioral

health supports remotely; to request from the Coronavirus Financial Advisory Committee funding for grants to local education agencies and creation of a public postsecondary digital campus totaling \$34 million; and to forward an additional recommendation to the Governor for Governor's Emergency Education Relief (GEER) funding use as identified in Handout 1. The handout identified six areas the grants to the school districts could be used for, devices, connectivity, infrastructure, adaptive technology, learning management system, and professional development around remote instruction or the use of a learning management system. From the ESSER 10% SEA reserve funds, \$1M was set aside for professional development for providing social emotional/behavioral health

At the July 15, 2020 Special Board meeting the Board approved the methodology for determining amounts each LEA is eligible to receive from the ESSER 10% SEA Reserve funds and CFAC funds as identified in Attachment 2 of the agenda material with priority for ESSER 10% SEA Reserve funding for the purchase or enhancement of a learning management system, while not limiting the use of these funds to a learning management system.
