BACKGROUND/DISCUSSION

In accordance with Section 33-312, Idaho Code, the Board of Trustees of Mountain View School District #244 have submitted a proposal for division of the district into two districts: Clearwater School District #245 and Grangeville School District #246. The Board of Trustees of Mountain View School District #244 conducted four (4) community hearings, as required, during October and November 2024. On November 6, 2024, the Mountain View #244 Board of Trustees met and approved a motion to submit the proposal for district division to the State Board of Education.

The current boundaries of Mountain View #244 School District extend from the Oregon to Mountain borders, covering 8,300 square miles. The district is rural and remote, with a population within district boundaries of 17,593. The district operates five (5) schools in Elk City, Grangeville, and Kooskia, with enrollment ranging from 13 to 509 students. The district division proposal would place the schools in Elk City and Kooskia into Clearwater School District, while the Grangeville schools would be placed into Grangeville School District. The proposed division places students the schools where families historically sent their students. The Board of Trustees of Mountain View School District #244 took both students' current school enrollment and division of Idaho's counties population into consideration when proposing the new boundaries and trustee zones of the new school districts. The legal descriptions and maps of the proposed school district boundaries and trustee zone boundaries are included as Appendices A - C.

IMPACT

If the Board approves the proposed proposal under Section 33-312, Idaho Code, the proposal shall be submitted to voters within the school district boundaries. If the proposal is approved by the electors, the Superintendent of Public Instruction shall make an order for the boundaries of the resulting school districts to be formally established, the legal descriptions of the district boundaries shall be finalized, and the process of identifying trustees for the new trustee zones will be implemented.

Upon review of the materials submitted, the Idaho Department of Education verifies that Mountain View's proposal is complete and meets the eligibility requirements for division of a school district under section 33-312, Idaho Code. The Department will present the proposal to the State Board of Education.

Rationale

This school district division plan has been developed for the following reasons:

- 1. Thomas Jefferson said, "Government closest to the people governs best."

 Mountain View School District is very large, spanning from the Montana border to the Oregon border making Trustee Zones very large. Two smaller districts may be able to better and more directly serve their communities.
- 2. Idaho has many small districts across the state that are the pride of their communities, because people take pride in what is theirs. Creating smaller districts may allow more patrons to take ownership in their local schools.
- 3. Various groups of patrons of Mountain View School District have been discussing a deconsolidation of the district since 2006 when Riggins separated from the then Mountain View School District #241 creating Riggins School District #243 and Mountain View School District #244.
- 4. Levy election results for the past ten (10) years indicate that there are differences in what our communities feel is important for the District, and therefore what they are willing to support through the levy process.
- 5. It is difficult for our diverse communities to be dependent on each other to secure funding when we have different visions for our schools. In this large geographic area, it is nearly impossible for five (5) School Trustees to meld any cohesive vision or build trusting relationships with the communities.
- 6. Smaller districts provide an additional level of local control.

In response to feedback from the patrons, the Trustees of Mountain View School District #244 propose the following ballot question in regard to school division to be decided at the May 2025 election.

QUESTIONS: Shall the Board of Trustees of School District #244, Idaho County, State of Idaho, authorize the deconsolidation of Mountain View School District #244, forming Clearwater Valley School District #245 and Grangeville School District #246? For the purposes stated above, all as provided in the Resolution adopted by the Board of Trustees on October 23, 2024.

1. 0 Introduction

1.1 Community Information

Mountain View School District #244 administrative offices are located in Grangeville, Idaho. Grangeville is located in Idaho County which is in North Central Idaho and is south of Lewiston and North of McCall. The County covers an area of 8,503 square miles. Idaho County is the largest county in the State of Idaho covering approximately 10% of the state. The county has a population of 17,593 (2022). A legal description of Mountain View School District #244 and the associated Trustee Zones can be found in Appendix A.

Mountain View School District's boundaries span from the state of Oregon to the state of Montana (8,300 sq. mi.) – covering more area than the entire state of New Jersey. However, with only 17,593 people, its population per square mile resembles that of Alaska. The school district borders the national "Frank Church Wilderness" area, and is surrounded by the Clearwater, Salmon, and Snake Rivers. Our local patrons, as well as guests, enjoy numerous outdoor activities including whitewater boating, snowmobiling, big game hunting, camping, hiking, and fishing.

The school district has schools located in the communities of Elk City, Grangeville, and Kooskia, but also serves students in many of the outlying communities within Idaho County. The school district consists of five schools with an overall population of about 1062 students. School populations range from 13 to 509 students, with Elk City School having the fewest students and Grangeville Elementary/Middle School having the most students.

Our goal is to prepare students with the skills necessary to function in a larger world. To this end, we have developed a highly skilled and caring professional and support staff. Each student is treated with the respect and attention needed to succeed. Extensive

athletic, academic, and other extra-curricular activities are available to students. These activities complement our academic program and serve to offer activities for students that increase their sense of self-worth and inspire them to achieve academically so we can meet our mission of "Educational Excellence for All".

1.2 Economic Information

Grangeville

Grangeville is the county seat for Idaho County. It is home to approximately 3,550 (2022) people with an additional 2,325 in the outskirts of town bringing the zip code area to a population of 5,875+. The outskirts of Grangeville have experienced an impressive growth of over 19% since 2000.

The town sits on the cross roads of US Highway 95 and Idaho State Highway 13. Just outside of Grangeville is the Idaho County Airport which provides air access into Grangeville and to the area's extensive recreation opportunities. Grangeville is home to Syringa Hospital and Clinics offering a wide variety of health services often only found in larger communities. Mountain View School District is headquartered in Grangeville serving the community with an Elementary/Middle School and High School that pride themselves on providing Educational Excellence for All.

Grangeville's major employers include Idaho County, Syringa Hospital and Clinics, Idaho Forest Group, Advanced Welding and Steel, United States Forest Service, Mountain View School District, and Les Schwab Tires.

According to the Census Bureau's On the Map: In 2011, there were about 1,280 people who were employed in the Grangeville zip code (and of course most of those would be in the city limits or very close to the city limits) who lived outside the zip code area, so were commuting from Cottonwood, Kamiah, Elk City, etc.

There is always a time lag with the <u>On the Map</u> data, but given that Grangeville's employment has increased since then, if commuters increased proportionately, there probably are about 1,350 people commuting now.

Kooskia

Located near US Highway 12 along the Clearwater River, Kooskia is a gateway to the Clearwater and Nezperce National Forests and the Selway Bitterroot Wilderness area. A little over 574 (2022) people call Kooskia home with an additional 1,500+ people living outside of Kooskia bringing the zip code area population to approximately 2,074.

The community is served by Mountain View School District including an elementary school and a junior/senior high school. Syringa Hospital has a clinic in Kooskia providing access to family medicine and physical therapy five days a week.

Kooskia's major employers include the United States Forest Service, 5 Star Forestry, Mountain View School District, Idaho Stage, and the Kidder-Harris Highway District.

According to the Census Bureau's On the Map in 2011, Kooskia had 170 people working in the zip code area with 166 of those commuting to Kooskia for work and 14 people both living and working in Kooskia. 486 people who live in the Kooskia area commute to another community for work.

The plan includes five trustee zones each for both the Proposed Clearwater Valley School District #245 and Proposed Grangeville School District #246. Trustee zones were created following current voting precincts in the proposed districts.

33-404 Places Elections to Be Held

The deconsolidation election will be held under the direction of the Idaho County Commissioners, Idaho County, Idaho.

33-505 Board of Trustees, Districts Newly Created

The Idaho State Board of Education, at its first meeting following receipt of notice of the creation of new school districts by the division of a district, shall appoint a board of trustees for each new district, to serve until January 1 following the next election for school district trustees.

2.0 Proposal for Division - Boundaries and Zones

2.1 Proposed Geographic Divisions

It is proposed that there be formed from the present Mountain View Joint School District #244, Idaho County, State of Idaho, two districts. The legal description for the proposed Clearwater Valley School District #245 (School District #245, Idaho County, State of Idaho) is included in Appendix B. This new district would be comprised of much of current Mountain View School District Trustee Zones 2 and 4 making the Proposed Clearwater Valley School District #245. This will include the communities of Kooskia, Stites, Harpster, Clearwater, and Elk City. Based on the 2020 census, the population of the proposed Clearwater Valley School District #245 is 4,609.

Much of the current Mountain View School District #244 Trustee Zones 1, 3 and 5 will make up the Proposed Grangeville School District #246. The legal description for the proposed Grangeville School District #246 (School District #246, Idaho County, State of Idaho) is included in Appendix B. This new district would include the communities of Grangeville, Fenn, Mount Idaho, and Whitebird. Based on the 2020 census, the population of the proposed Grangeville School District #246 is 6,649.

A variety of factors were considered in making the proposed district boundaries. Primary consideration was given to where families historically sent their students to school. Those who have always sent their students to Clearwater Valley remain in that proposed district and those who have always sent their students to Grangeville remain in that proposed district. Note: The odd strip of land on the northwest corner of the new district is intentional. Historically, the families who owned that land have all gone to Clearwater Valley, and it made sense to have them part of the proposed Clearwater School District 245.

Current bus routes and school boundaries were used to develop the proposed district lines. The current bus routes and school boundaries were developed following

geographic landmarks. Every effort was made to avoid bus routes assigned to the Mount Idaho and Harpster grades as they can be difficult to navigate in winter months.

Size, economy, and culture of the various communities impacted by this decision was considered. Kooskia (CV) and Elk City are smaller communities, have economies tied to forestry, and have voted similarly in elections. Grangeville is a larger community and has an economy more tied to agriculture.

Consultation with county officials focused on making the future election and taxing districts as straightforward as possible. Trustee zones were created using existing voter precincts.

By including Elk City in the new district with Clearwater Valley, the values of taxable properties in the new districts are more similar. In doing so, Elk City and CV will have more property value per student which could help with future levies if necessary.

The legal description of the proposed Clearwater Valley School District #245 and proposed Grangeville School District #246 is included in Appendix B. A map of the two proposed new districts is included in Appendix C.

Further, it is proposed that in accordance with Idaho Code 33-1402 Transfer of Pupils, the students of Elk City would have the right to enroll in proposed Grangeville School District #246 under Open Enrollment. However, this plan would provide students from the Elk City Region Open Enrollment opportunities regardless of class or program enrollment limits in perpetuity. Additionally, those students that are currently enrolled in a Mountain View School District School other than their boundary school (Clearwater Valley Students currently attending school in Grangeville and/or Grangeville Students currently attending school at Clearwater Valley) will be able to complete their K/12 education in the school district of their choice.

2.2 Proposed Trustee Zones

Proposed Clearwater Valley School District #245

It is proposed that Clearwater Valley School District #245 (School District #245, Idaho County, State of Idaho) have five (5) trustee zones using current precinct boundaries in both proposed districts. (See Appendix B for legal descriptions of the five proposed zones with Appendix C for a map showing the five proposed zones.)

Proposed Grangeville School District #246

It is further proposed that the new Grangeville School District #246 (School District #246, Idaho County, State of Idaho) have five (5) trustee zones using current precinct boundaries in both proposed districts. (See Appendix B for legal descriptions of the five proposed zones and Appendix C for a map showing the five proposed zones.)

2.3 Methodology for Determination of Proposed Trustee Zones

Consultation with county officials focused on making the future election and taxing districts as straightforward as possible. Trustee zones were created using existing voter precincts.

3.0 Proposal for Division - Finance

3.1 Financial Division - Overview

The division of an Idaho school district requires that there be new taxable market value calculations, a division of assets and a division of liabilities (including bonded indebtedness). In addition, there are a number of other operational factors (transportation, personnel, contractual obligations, food service, technology, etc.) that are affected by a school district division that should be addressed in a division plan. The following sections address those relevant issues.

3.2 Estimated Market Values

Proposed Clearwater Valley School District #245

As of September 5, 2024 the total value of the existing Mountain View School District #244 was \$1,625,867,816. In September 2024, Idaho County Assessor Kim Nuxoll, estimated the proposed Clearwater Valley School District #245 would have a taxable market value of approximately \$706,077,647. For the proposed Clearwater Valley School District #245, the average daily attendance (ADA) for the 2023-2024 school year was approximately 297.02. The total ADA for the existing Mountain View School District #244 was approximately 1,044.46. Therefore, the proposed Clearwater Valley School District #245 would have approximately 43.43% of the total taxable market value of the existing Mountain View School District #244 and 28.44% (28.5%) of the ADA. The proposed Clearwater Valley School District #245 would have approximately \$2,377,206 taxable market value per ADA.

Proposed Grangeville School District #246

As of September 5, 2024 the total value of the existing Mountain View School District #244 was \$1,625,867,816. In September 2024, Idaho County Assessor Kim Nuxoll, estimated the proposed Grangeville School District #246 would have a taxable market value of approximately \$919,790,169. For the proposed Grangeville School District #246, the average daily attendance (ADA) for the 2023-2024 school year was approximately 747.44. The total ADA for the existing Mountain View School District #244 was approximately 1,044.46. Therefore, the proposed Grangeville School District #246 would have approximately 56.57% of the total taxable market value of the existing Mountain View School District #244 and 71.56% (71.5%) of the ADA. The proposed Grangeville School District #246 would have approximately \$1,230,587 taxable market value per ADA.

Under Idaho State school finance laws, the dollar amount distributed to each district under the unit allocation formula is essentially derived by dividing the total allocation by the number of units plus adjustments. Therefore, whenever the total number of units increases, for whatever reason, the amount distributed decreases. As detailed in Exhibit 3-9, funding for the division of existing Mountain View School District #244 costs \$8,801 more than if Mountain View School District #244 did not divide. This would require the State of Idaho to lower the funding of other Idaho school districts by a small amount to fund this division.

3.5 Division of Assets

Real and Personal Property

It is proposed that all real and personal property presently located within the proposed legal boundaries of the proposed Clearwater Valley School District #245 will be owned by that proposed new district.

It is proposed that all real and personal property presently located within the proposed legal boundaries of the proposed Grangeville School District #246 will be owned by that proposed new district.

It is proposed that the new Grangeville School District #246 pay the proposed new Clearwater Valley School District #245 a portion of the estimated value of the shared technology equipment, and furniture and equipment from the district office building (such amount to be proportional to the ADA for each proposed new district). Prepaid curricular subscriptions will be separated proportional to the ADA for each proposed new district. The amount paid by the proposed Grangeville School District #246 shall be placed in a plant facility fund in the proposed new Clearwater Valley School District #245, should the proposal for division be approved by the voters as per applicable sections of Idaho Code.

Transportation and Service Vehicles

It is proposed that all buses and maintenance equipment presently located within the proposed legal boundaries of the proposed Clearwater Valley School District #245 will be owned by that proposed new district.

It is proposed that all buses and maintenance equipment presently located within the proposed legal boundaries of the proposed Grangeville School District #246 will be owned by that proposed new district.

It is proposed that the proposed new Grangeville School District #246 pay the proposed Clearwater Valley School District #245 a portion of the estimated value of any shared service vehicles, in a manner proportional to the ADA for each proposed new district. (The payment may be in the form of vehicles.) The division shall be based on the approximate age of the vehicles. The age basis for shared service vehicles shall be the fixed asset list of the existing Mountain View School District #244 for the school year 2024-2025.

Technology Infrastructure

It is proposed that all technological equipment presently located within the proposed legal boundaries of the proposed Clearwater Valley School District #245 will be owned by that proposed new district.

It is proposed that all technological equipment presently located within the proposed legal boundaries of the proposed Grangeville School District #246 will be owned by that proposed new district.

It is proposed that the proposed new Grangeville School District #246 pay the proposed new Clearwater Valley School District #245 a portion of the estimated value of any shared technological equipment, in a manner proportional to the ADA for each proposed new district. (The payment may be in the form of equipment.) The division shall be based on the approximate value of the equipment. The value basis for equipment shall be the fixed asset list of the existing Mountain View School District #244 for the school year 2024-2025.

District Office Equipment and Furniture

It is proposed that all district office equipment and furniture presently located within the proposed legal boundaries of the proposed Clearwater Valley School District #245 will be owned by that proposed new district.

It is proposed that all district office equipment and furniture presently located within the proposed legal boundaries of the proposed Grangeville School District #246 will be owned by that proposed new district.

It is proposed that the proposed new Grangeville School District #246 pay the proposed new Clearwater Valley School District #245 a portion of the estimated value of any District Office Equipment and Furniture, in a manner proportional to the ADA for each proposed new district (The payment may be in the form of equipment or furniture.) The division shall be based on the approximate value of the equipment or furniture. The value basis for equipment and furniture shall be the fixed asset list of the existing Mountain View School District #244 for the school year 2024-2025.

Consumable Supplies

It is proposed Mountain View School District #244 disperse all consumable supplies in the district office building and any other central service facility between Clearwater Valley School District #245 and Grangeville School District #246 in a manner proportionate to the ADA for each proposed new district.

Cash - General Fund

It is proposed that any cash balance of the general fund shall be divided between the two new districts using the same state equalization formula in place at the beginning of Fiscal Year 2026.

Cash - Supplemental Levy for General Fund

It is proposed that any cash received from a supplemental levy or emergency levy approved by the existing Mountain View School District #244 after the final payment for Fiscal 2025 be placed in separate funds proportional to the 2025 taxable market value for each proposed new district.

Cash - Agency Funds

It is proposed that agency funds for student activity accounts, staff activity accounts, or special revenue accounts shall remain with their respective schools.

Cash - Special Project Funds

It is proposed that any cash balance of any special project fund shall be divided, such amount to be proportional to the 2025 taxable market value for each proposed new district. Those special project funds dedicated to specific schools will stay with that school (e.g. Title 1, Johnson O'Malley, etc.).

Cash - Secure Rural Schools

It is proposed that any cash balance of any Secure Rural Schools Fund shall be divided between the new districts based on a per-pupil basis.

Cash - School Modernization Facility Funds

It is proposed Mountain View School District #244 disperse the School Modernization Facility Funds between Clearwater Valley School District #245 and Grangeville School District #246 in a manner proportionate to the ADA for each proposed new district.

Cash - Plant Facility Funds

The existing Mountain View School District #244 does not have a plant facility fund.

3.6 Division of Liabilities

Certified Personnel Contracts

It is proposed that the contracts of all certified personnel presently assigned to school buildings be assumed by their respective districts according to the building or department assignment at the time of legal division.

The Superintendent, Nurse, Speech and Language Pathologist, Federal Programs/Curriculum and Assessment Director, Special Education Coordinator, and Special Education Preschool Teacher are shared certified positions in the current

Mountain View School District #244. It is recognized that both districts will have a need for these assignments, however the assignments in the proposed districts may differ based on enrollment.

The superintendent will make a certified personnel assignment recommendation based on enrollment. Further, beyond enrollment needs, the superintendent will use the following criteria for those assignments: (1) licenses or certifications required for the assignment, (2) professional skills necessary to efficiently and effectively complete the assignment, (3) employee preference (by seniority), and (4) by lot if necessary.

Bond Indebtedness

At this time, there is no bonded indebtedness for the existing Mountain View School District #244.

LID

At this time, there is no LID obligation for the existing Mountain View School District #244.

COP's and Notes

At this time, there are no COP's or notes for the existing Mountain View School District #244.

Legal Claims

At this time there are no legal claims against the existing Mountain View School District #244.

3.7 Division - Other Considerations

At-Will Employees

It is proposed that the employment of "at-will" employees (those not under contract) assigned to school buildings and departments be assumed by their districts according to the building or department assignment at the time of division.

It is proposed that the employment of "at-will" employees (those not under contract) not assigned to school buildings be divided among the two new districts. Approximately 28.5% of those employees may be offered assignment to the proposed new Clearwater School District #245 and approximately 71.5% of those employees may be offered assignment to the proposed new Grangeville School District #246. The superintendent of schools of the existing Mountain View School District #244 shall make those offers of assignment. The superintendent will use the following criteria for those assignments: (1) licenses or certifications required for the assignment, (2) professional skills necessary to efficiently and effectively complete the assignment, (3) employee preference (by seniority), and (4) by lot if necessary.

Records

It is proposed that all records pertaining to the proposed new districts shall be transferred to the newly created district upon division. The records shall then become the property of that newly created district. The placement of records pertaining to the existing Mountain View School District #244 will be determined through consultation with the Idaho State Department of Education.

Transition Issues

It is proposed that the two newly created districts, if approved by the voters, shall be considered sub-districts of the existing Mountain View School District #244 from the

time of the legal division until the time of the fiscal division. The newly appointed Trustees for the proposed Clearwater Valley School District #245 and Grangeville School District #246 will form a Joint Powers Board until the legal fiscal division. (Please see Appendix F)

It is proposed that the existing Board of Trustees of School District #244 shall act as a joint powers board for the two sub-districts from the time of legal division until the time of fiscal division.

It is further proposed that the authorization for receipt of revenues and authorization for expenditures be made by the joint powers board from the time of legal division until the time of fiscal division.

It is recommended that the Joint Powers Board of the newly created districts work together to establish a transition plan for a smooth fiscal transition, a smooth transition of personnel, and other issues related to the establishment of the two new school districts.

3.8 Critical Timeline and Effective Dates

IDE

The timeline for a division is driven by two main factors:

- a. The accumulation of necessary financial data from the school district, the county, and the State, and
- b. The timing of the election, which can only be conducted by the county clerk.

Therefore, the division plan needs to be finalized in late October to submit to the Idaho State Department of Education and the Idaho Board of Education. If the Idaho Board of Education approves the plan, the election would be conducted at the May 2025 election date.

Therefore, should the voters approve the division plan, it is proposed that the effective date for the governance of the districts would be on the date the State Board of Education appoints a Board of Trustees for each newly formed school district. Further, it is proposed that the effective date for the fiscal (operational) division of the districts would be on July 1, 2026. Further, it is proposed that upon certification of the election to divide the district that a Joint Powers Board would operate the "combined" districts until operational (fiscal) separation on June 30, 2026.




Map of the proposed Clearwater Valley School District #245

33-305. Naming and numbering school districts. Each school district as the same is organized on the effective date of this act shall bear the same number as theretofore. Excepting specially chartered school districts, each school district operating a secondary school, or secondary schools, on said date shall be designated by number and county, after the following style:

School District No. .., County, State of Idaho, or Joint School District No. ..,, (and) Counties, State of Idaho.

Each school district which, on the effective date of this act, is maintaining only an elementary school, or elementary schools, shall be designated after the following style:

Elementary School District No. .., County, State of Idaho, or Joint Elementary School District No. ..,, (and) Counties, State of Idaho.

Joint districts shall be designated by the same number in each county in which the district lies, or shall lie.

Wherever the term "school district" appears in this act, it shall mean and include any school district, joint school district, elementary school district, joint elementary school district or specially chartered school

district, unless a more limited meaning is clearly expressed and intended, or unless any provision of a charter is contrary thereto.

33-306. Boundaries of school districts. There shall be no part of the area of the state of Idaho not included in the area of some school district.

A legal description of the boundaries of each school district, as now or hereafter established, shall be kept by the state board of education and by the board of county commissioners in each county in which any school district, or any part thereof, shall lie.

33-310. Consolidation of school districts. The boards of trustees of two (2) or more contiguous school districts may submit to the state board of education a plan for the consolidation of their districts into a single new district.

The plan shall contain as a minimum the following, and in addition any other information required by the state board of education:

- (1) A map or maps showing the boundaries of the proposed new district, the boundaries of the component consolidating districts, the location of existing schoolhouses or other facilities of the component districts, the proposed trustee zones, and the proposed transportation routes if any;
- (2) A legal description of the boundaries of the proposed new school district and of the trustee zones proposed, with estimates of the population in each such zone;
- (3) The assessed value of taxable property of each component consolidating district and of the entire proposed new district;
- (4) Outstanding general obligation bonds of any component consolidating district, sinking funds accumulated, and estimated proceeds of sinking fund levies in process of collection;
- (5) Whether any component district has established a plant facilities reserve fund, and if so the amount on hand in such fund, the obligations against the fund, and the levy being made for such fund together with estimate of the proceeds of such levy in process of collection;

- (6) The amount of any outstanding and unpaid bonds that will become the obligation of the subdistricts, pursuant to section 33-311, Idaho Code, after the application of any plant facility reserve funds, pursuant to section 33-901, Idaho Code. The plan shall also show for each subdistrict the estimated amount of state subsidies to be received, the estimated bond levy rate and the year in which the last levy will be made;
- (7) If a joint district, the designation of the home county;
- (8) The official name and number of the proposed new district; and
- (9) How the property, real and personal, of former districts shall vest in the new district.

Before submitting any proposal for consolidating school districts to the state board of education, the board of trustees of each proposing district shall first call and cause to be held, within said district, a hearing on the proposal. Notice of the time and place of such hearing shall be given, by each such district, by two (2) publications in a newspaper of general circulation in the district, the first and last publications being not less than six (6) days apart.

At such hearings, any school district elector or taxpayer of the district may appear and be heard, and may request any information from the board of trustees, concerning the proposed consolidation. Records of the hearings shall be entered in the minutes of each board of trustees and shall be included with the plan of proposed consolidation if and when it is submitted to the state board of education.

Following any hearing, it shall be within the discretion of the board of trustees of any proposing district whether it shall further proceed in the plan for consolidating the districts.

33-311. Plan of consolidation submitted to electors. The state board of education may approve or disapprove any plan proposing consolidation, and if it approves the same the department of education shall give notice thereof to the board of trustees of each school district proposing to consolidate and to the board of county commissioners in each county in which the proposed consolidated district would lie. Notice to the board of county commissioners shall include the legal description of the boundaries of the proposed consolidated district and a brief statement of the approved proposal, and shall be accompanied by a map of the proposed consolidated district.

Not more than ten (10) days after receiving the notice from the state department of education, each board of county commissioners receiving such notice shall enter the order calling for an election on the question of approving or disapproving, and shall cause notice of such election to be published. The notice shall be published, the election shall be held and conducted and its results canvassed, in the manner and form of title 34, Idaho Code.

If the qualified school electors of any one (1) district proposing to consolidate, and voting in the election, shall constitute a majority of all such electors voting in the entire area of the proposed consolidated district, the proposed consolidation shall not be approved unless a majority of such electors in such district, voting in the election, and a majority of such electors in each of the remaining districts, voting in the election, shall approve the proposed consolidation.

If the qualified school electors in no one (1) of the districts proposing to consolidate, and voting in the election, constitute a majority of all such electors voting in the entire area of the proposed consolidated district, the proposed consolidation shall not be approved unless a

majority of all such electors in each district, voting in the election, shall approve the proposed consolidation.

In any plan of consolidation the existing bonded debt of any district or districts proposing to consolidate, shall not become the obligation of the proposed consolidated school district. The debt or debts shall remain an obligation of the property within the districts proposing the consolidation. Upon voter approval of the proposed consolidation, the districts proposing to consolidate shall become subdistricts of the new district as if they had been created under the provisions of section 33-351, Idaho Code. The subdistricts shall be called bond redemption subdistricts. The powers and duties of such bond redemption subdistricts shall not include authority to incur new indebtedness within the subdistricts.

When a consolidation is approved, as hereinabove prescribed, a new school district is thereby created. The board of canvassers shall thereupon promptly notify the state department of education and the affected school districts of such result. The superintendent of public instruction shall make an appropriate order showing the creation of the district, a legal description of its boundaries, and the legal descriptions of the boundaries of the affected school districts as prescribed in section $\underline{33}$ - $\underline{308}$, Idaho Code.

33-312. Division of school district. A school district may be divided so as to form not more than two (2) districts each of which must have contiguous boundaries, in the manner hereinafter provided, except that any district which operates and maintains a secondary school or schools shall not be divided unless the two (2) districts created out of the division shall each operate and maintain a secondary school or schools immediately following such division.

A proposal to divide a school district may be initiated by its board of trustees and submitted to the state department of education. Such proposal shall contain all of the information required in a proposal to consolidate school districts as may be relevant to a proposal to divide a school district. It shall also show the manner in which it is proposed to divide or apportion the property and liabilities of the district, the names and numbers of the proposed new districts, and legal description of the proposed trustee zones.

Before submitting any proposal to divide a school district, the board of trustees shall hold a hearing or hearings on the proposal within the district. Notice of such hearing or hearings shall be posted by the clerk of the board of trustees in not less than three (3) public places within the district, one (1) of which places shall be at or near the main door of the administrative offices of the school district, for not less than ten (10) days before the date of such hearing or hearings.

The department of education shall present any such proposal to the state board of education, which may approve or disapprove the proposal, and the department of education shall give notice thereof in the manner of a proposal to consolidate school districts; except, that the state board of education shall not approve any proposal which would result in a district to be created by the division having or assuming a bonded debt

in an amount exceeding the limitations imposed by law, or which would leave the area of any city in more than one (1) school district.

If the state board of education shall approve the proposal to divide the district, notice of the election shall be published and the election shall be held subject to the provisions of section 34-106, Idaho Code. The election shall be conducted, and the ballots shall be canvassed, according to the provisions of title 34, Idaho Code. The division shall be approved only if a majority of all votes cast at said special election by the school district electors residing within the entire existing school district and voting in the election are in favor of the division of such district, and a majority of all votes cast at said special election by the qualified voters within that portion of the proposed new district having a minority of the number of qualified voters, such portion to be determined by the number of votes cast in each area which is a contemplated new district, are in favor of the division of the district, and upon such approval two (2) new school districts shall be thereby created. The organization and division of all school districts which have divided since June 30, 1963, are hereby validated.

If the division is approved, as herein provided, two (2) new school districts are thereby created. The board of canvassers shall thereupon promptly notify the state department of education and the affected school districts of such result. The superintendent of public instruction shall make an appropriate order showing the creation of the districts and a legal description of the boundaries, and the legal descriptions of the affected school districts shall be altered, as prescribed in section $\underline{33}$ – $\underline{307}$, Idaho Code.

33-313. Trustee zones. (1) Each elementary school district shall be divided into three (3) trustee zones and each other school district shall be divided into no fewer than five (5) nor more than nine (9) trustee zones according to the provisions of section 33-501, Idaho Code. A school district that has had a change in its district boundaries because of consolidation on and after January 1, 2008, shall divide trustee zones so that each former district in the new district shall not be split into different trustee zones, unless the provisions of subsection (2) of this section cannot be satisfied.

- (2) Any proposal to define the boundaries of the several trustee zones in each such school district shall include the determination, where appropriate, of the number of trustee zones in such district, and the date of expiration of the term of office for each trustee. The boundaries of the several trustee zones in each such school district shall be defined and drawn so that, as reasonably as may be, each such zone shall have approximately the same population.
- (3) Whenever the area of any district has been enlarged by the annexation of all or any part of another district, or by the correction of errors in the legal description of school district boundaries, any such additional territory shall be included in the trustee zone or zones contiguous to such additional territory until such time as the trustee zones may be redefined and changed. Trustee zones may be redefined and changed not more than once every five (5) years in the manner hereinafter provided.

- A proposal to redefine and change trustee zones of any district may be initiated by its board of trustees and shall be initiated by its board of trustees at the first meeting following the report of the decennial census, and submitted to the state board of education, or by petition signed by not less than fifty (50) school electors residing in the district, and presented to the board of trustees of the district. Within one hundred twenty (120) days following the decennial census or the receipt of a petition to redefine and change the trustee zones of a district the board of trustees shall prepare a proposal for a change which will equalize the population in each zone in the district and shall submit the proposal to the state board of education. Any proposal shall include a legal description of each trustee zone as the same would appear as proposed, a map of the district showing how each trustee zone would then appear, and the approximate population each would then have, should the proposal to change any trustee zones become effective.
- (5) Within sixty (60) days after it has received the said proposal the state board of education may approve or disapprove the proposal to redefine and change trustee zones and shall give notice thereof in writing to the board of trustees of the district wherein the change is proposed. Should the state board of education disapprove a proposal, the board of trustees shall, within forty-five (45) days, submit a revised proposal to the state board of education. Should the state board of education approve the proposal, it shall notify the school district, the trustee zones shall be changed in accordance with the proposal and a copy of the legal description of each trustee zone and map of the district showing how each trustee zone will appear shall be filed by the school district with the county clerk.
- (6) At the next regular meeting of the board of trustees following the approval of the proposal the board shall appoint from its membership a trustee for each new zone to serve as trustee until that incumbent trustee's term expires. If the current board membership includes two (2) incumbent trustees from the same new trustee zone, the board will select the incumbent trustee with the most seniority as a trustee to serve the remainder of his term. If

both incumbent trustees have equal seniority, the board will choose one (1) of the trustees by the drawing of lots. If there is a trustee vacancy in any of the new zones, the board of trustees shall appoint from the patrons resident in that new trustee zone, a person from that zone to serve as trustee until the next annual meeting. At the annual election a trustee shall be elected to serve during the term specified in the election for the zone. The elected trustee shall assume office at the annual meeting of the school district next following the election.

33-402. Notice requirements. (1) Notice of annual meeting of elementary school districts as provided for in section 33-510, Idaho Code, and of intent to discontinue a school, as provided for in section 33-511, Idaho Code, and annual budget hearing as provided for in section 33-801, Idaho Code, shall be given by posting for not less than ten (10) days, and publishing once in a newspaper as provided in section 60-106, Idaho Code, published within the district, or, if there be none, then in a newspaper as provided in section 60-106, Idaho Code, published in the county in which such district lies. If more than one (1) newspaper is printed and published in said district or county, then in the newspaper most likely to give best general notice of the election within said district; provided that if no newspaper is published in the said district or county, then in a newspaper as provided in section 60-106, Idaho Code, most likely to give best general notice of the election within the district. If a financial emergency has been declared pursuant to section 33-522, Idaho Code, the notice of annual meeting and the notice of the annual budget hearing shall be posted pursuant to subsection (2) of this section, for not less than five (5) days, and by such further notice as shall provide reasonable notice to the patrons of the school district if publication in a newspaper is not feasible.

- (2) Notices calling for bids for the acquisition, use, or disposal of real and personal property as provided for in section 33-601, Idaho Code, and contracting for transportation services as provided for in section 33-1510, Idaho Code, shall be given in a newspaper of general circulation as required by chapter 1, title 60, Idaho Code, except that the notice for contracting for transportation services shall be made not less than four (4) weeks before the date of opening bids.
- (3) Proof of posting notice shall be upon the affidavit of the person posting the same; and proof of publication shall be upon the affidavit

of the publisher of the newspaper or newspapers respectively. Such affidavits shall be filed with the board by the clerk responsible for the posting and the publishing of said notice.

CHAPTER 4

SCHOOL ELECTIONS

33-404. Places elections to be held. In elections involving excision and annexation of territory, or the consolidation of school districts, or the division of a school district, each notice of election shall designate that polling places shall be established, as follows:

In an election involving excision and annexation of territory, polling places shall be established pursuant to section $\underline{34-302}$, Idaho Code, in the district to which the territory or area is to be annexed; in the territory or area to be annexed; and in the remainder of the school district from which the territory or area is to be excised.

In an election involving consolidation of school districts, polling places shall be established pursuant to section 34-302, Idaho Code.

In an election involving the division of a school district, polling places shall be established pursuant to section 34-302, Idaho Code.

In any school election held within a joint school district, polling places shall be designated and established pursuant to section $\underline{34-302}$, Idaho Code, within such district, in each county.

CHAPTER 5

DISTRICT TRUSTEES

33-505. Board of trustees, district newly created. (1) Within ten (10) days after the entry of any order creating a new school district by the consolidation of districts or parts thereof, the trustees of all school districts involved in the consolidation shall meet at the call of the state superintendent of public instruction or his designee and, from their number, shall select a board of trustees of the new district representing each of the merged districts in an equal number to serve as follows: if two (2) districts consolidated, one (1) member representing the board of trustees of each district shall serve until the annual election of trustees next following; one (1) member representing the board of trustees of each district shall serve until the annual election the following year; and one (1) member appointed by the other four (4) members shall serve until the annual election in the year after that. If three (3) or more districts consolidated, three (3) members shall serve until the annual election of trustees next following; three (3) members shall serve until the annual election the following year; and one (1) member appointed by the other six (6) members shall serve until the annual election in the year after that. If the number of merged districts is greater than three (3), the superintendent of public instruction shall appoint as equally as possible from trustees of the previous districts so that each district, if possible, has representation on the consolidated district's board of trustees. The superintendent shall stagger the terms of his appointments so that an equal number of appointees' terms expire annually and those trustees shall sit for election. Thereafter, all trustees who are elected shall serve terms as provided in section 33-501, Idaho Code, for a board of trustees of a school district. The board of trustees shall report the names of said trustees to the state board of education. The board of trustees of the newly consolidated school district shall expeditiously redraw the trustee zones pursuant to section $\underline{33-313}$, Idaho Code.

- (2) The state board of education, at its first meeting next following receipt of notice of the creation of new school districts by the division of a district, shall appoint a board of trustees for each such new district, to serve until January 1 following the next election for school district trustees.
- (3) Boards of trustees selected or appointed as in this section provided shall forthwith meet and organize as provided in section $\underline{33-506}$, Idaho Code, and thereupon the board of trustees of any district, the whole of which has been incorporated within the new district, or which was divided as the case may be, shall be dissolved and its powers and duties shall cease. Prior to the notice of annual election of trustees next following, the board of trustees of each school district created by consolidation or by division of districts shall determine by lot or by agreement from which of the trustee zones the trustees therefor shall be elected. Thereafter each trustee shall be elected for a term of four (4) years.

Appendix H

Questions and Answers

- 1. Is it legal for a school district to divide in Idaho?
 - a. Yes, Idaho Code 33-312 provides for the division of a school district provided certain procedures are followed.
- 2. Who determines if the district is to divide?
 - a. Idaho Code prescribes a multilevel process. The steps are as follows:
 - i. The locally elected Board of Trustees develops a division plan.
 - ii. The locally elected Board of Trustees conducts at least three public hearings regarding the division plan.
 - iii. The locally elected Board of Trustees adopts the final plan and submits it to the State Board of Education.
 - iv. The State Board of Education reviews the plan and may reject it or approve the plan.
 - v. If the State Board of Education approves the plan, the county clerk conducts an election where the voters decide the issue. The county commissioners act as the board of canvassers.
 - vi. If the voters approve the division, the county commissioners notify the State Board of Education.
 - vii. The State Board of Education appoints new trustees to govern the new district.
- 3. Does the locally elected Board of Trustees determine how the district is to divide?
 - a. Yes, The locally elected Board of Trustees is charged with the responsibility of developing a division plan and the public hearings regarding that plan.
- 4. Does the locally elected Board of Trustees determine if the district is to divide once a division plan is adopted?
 - a. No. There are two more approvals that must occur if the local board of trustees approves the division plan. The State Board of Education may accept or reject the plan. But the voters have the final say after the division plan is approved by the State Board of Education.
- 5. Can an Idaho school district board of trustees define the time and place to run an election for the division of their school district?
 - a. No. An election for the division of a school district falls under Idaho Code 33-402 (e) and is operated under the full authority and control of the county clerk.
- 6. Why was the division line drawn where it was?

- a. The Board of Trustees felt that the line as presently drawn was least disruptive for students. The board considered the transportation routes, present community boundaries, future community growth and expansion, geographic factors, and property value factors. The decision to include Elk City in the Proposed Clearwater Valley School District #245 was based on current school attendance, geographic and economic similarities.
- 7. Must the ballot question for division include language obligating both new districts to a proportionate share of both assets and liabilities.
 - a. Yes. Idaho Code 33-312
- 8. What happens to unresolved litigation that a school district may have at the time of the division, should division occur?
 - a. Presently, there are no outstanding litigation cases. If the District should lose any case before division, the liability insurance carrier will pay all or most of the judgment. Any amount left to pay would be divided according to the taxable property values in the two newly formed districts.
- 9. Will taxes on my property increase as a result of division?
 - a. Not unless the voters of the district approve an increase. If the District divides, the voters in either of the two newly formed districts may vote to raise their taxes for a supplemental levy, plant facility levy, or a bond levy.
- 10. What happens to the agreement between the teachers' union and the District?
 - a. The terms and conditions of the Master Negotiated agreement with the Central Idaho Education Association expires on July 1, 2025. The terms and conditions of the Master Negotiated Agreement with the Central Idaho Education Association may be used in setting a new agreement.
- 11. What will be the effect of costs for special education in the two new districts if we divide?
 - a. It is uncertain. Presently, both state and federal law require public schools to provide a "free, appropriate, public education" for all handicapped students regardless of their handicap. Occasionally, a school district enrolls a student with a handicap that is so severe that the district must hire additional help or even contract with outside agencies to provide the child's education. Such action may impose a financial hardship on the district. Because of economies of scale, larger districts are usually better able to absorb or handle such costs. Smaller districts may have a more difficult time.
- 12. Can students transfer between the two school districts to attend a school of their choice?
 - a. Idaho Code 33-1402 outlines Open Enrollment procedures for school districts.

- 13. Can staff transfer between the two school districts to work in a school of their choice?
 - a. No. Once the district is divided, the two new districts are separate employers. If staff wanted to work in the other district, they would have to resign employment in their home district and be accepted for employment by the new district. A continuing contract employee leaving the employment of one district to transfer to another district loses their continuing contract status.
- 14. Will the two new districts be required to purchase new school facilities to house children?
 - a. No
- 15. What would be the effect of division on liability insurance, property insurance, and health insurance?
 - a. The liability and property insurance policies are based largely on property value and enrollment. Health insurance costs are determined through a bid process.
- 16. What will be the effect on Title 1 revenues?
 - a. Title 1 revenues are allocated using a "per pupil" formula based on free and reduced lunch counts.
- 17. What will be the effect on the Special Education revenues?
 - a. These funds are allocated using a "per pupil" formula.
- 18. What will be the effect of division on eligibility for "free and reduced" food service?
 - a. None. Free and reduced lunches will continue to be offered as per present practices.
- 19. What will be the effect of division on the contracted food services program?
 - a. The present contract could be continued under a joint powers agreement, or each district could contract separately.
- 20. What will be the effect of division on lottery revenues?
 - a. Lottery revenues are distributed on a formula basis and the formula is not expected to change. Those revenues are distributed to school districts by the State Department of Education.
- 21. What will be the effect of division on Secure Rural Schools fund revenues?
 - a. Secure Rural Schools funds are distributed by the county on a "per pupil" basis. It is proposed that any cash balance of any Secure Rural Schools Fund shall be divided between the new districts based on a per-pupil basis.
- 22. What will the effect of division on transportation reimbursement revenues?
 - a. Transportation reimbursement revenues will be divided equitably and should not change appreciably considering the numbers of riders and

route lengths. State support for the first year will be based on a calculation of costs per mile, costs per pupil, and school bus depreciation. Because the school bus vehicle assets will be divided based on their current assignment, both newly formed districts will have bus depreciation inventories that will nearly mirror the vehicle ages presently used by the existing Joint School District #244 bus depreciation inventory. In subsequent years, the transportation reimbursement will be based on actual costs for the prior year.

- 23. How would division affect each proposed new district's ability to bond?
 - a. Idaho districts presently can have total bonded indebtedness up to a statutory limit of 5% of their taxable assessed market value. Each new district will have full bonding capacity because there is no debt. Each new district would be able to bond up to their statutory limit if their votes approved a bond levy.
- 24. Is the smaller of the two districts being considered as part of the division plan large enough to be viable or is it too small?
 - a. There are a number of Idaho School Districts operating each year that are approximately the same size as the smaller one being considered here with 22.63 support units.
- 25. What is the timeline for this decision?
 - a. The Board of Trustees will consider a resolution at their October 23, 2024 Special Board Meeting.
 - b. If the Board votes to proceed, the proposal will be submitted to the Idaho State Department of Education to the Idaho Board of Education for a decision at their December or January meeting.
 - c. If the Idaho Board of Education approves the plan, a Special Election of voters in the current Mountain View School District #244 boundaries would occur in May of 2025.
 - d. If the voters approve the deconsolidation at that May 2025 election, the District would deconsolidate, forming Clearwater Valley School District #245 and Grangeville School District #246 on July 1, 2026.
- 26. Why is the election in May of 2025 but the deconsolidation wouldn't occur until June 30, 2026?
 - a. In order to develop a clear and responsible separation of the District and to provide the most equitable outcome for both districts, it is important to allow the Joint Powers Board of Trustees adequate time to direct the process of division. These decisions include but are not limited: staffing, funding, and contracted services. Ultimately, the time is needed to make the best decisions for our students.
