1. Governing Policy and ByLaws

The first reading of the governing Policy and Procedure for the DMC took place at the August Board meeting. The second reading will be at the October Board meeting. The Policy was reviewed by the Council and a few changes were made. The Council still needs to finalize their Bylaws. Andy will post the latest versions of these documents on the web site.

2. SLDS Project and ARRA deadline

Andy has 2 programmers on board, with the following responsibilities assigned:

- 1. File transfer piece secure upload FTP process
- 2. File upload process staging tables, errors and warning logs, etc.

Timeline: done by the end of this week, 16<sup>th</sup>

There was a lot of (too) detailed discussion about the SLDS project specifically related to the submission of the PostSecondary data. Postsecondary institutions will upload 5 files. The 5 files will include end of term data for summer 2010, fall 2010 and spring 2011. Andy went through STUDENT table last week with the programmer. This week he will go through REGISTRATION and SECTION table, and plans to have the final two (DEGREE/CERT and RACE/ETHNICITY) reviewed with the programmer by Monday.

Andy will revisit the column in the Data Dictionary that indicates whether a field can be null if file transferred. The EDUID is one of those required fields.

Andy will schedule a block of time next week with the Institutional Researchers from all of the institutions to talk about the requirements to meet the ARRA deadline. He will need an initial set of data from all of them, and will have to demonstrate that he could run the report. No report is submitted and no visit is expected, according to Andy.

Andy will send the Council a copy of the Security Policy that is required for the ARRA deadline. It has to be approved by the Council.

3. Access & Security Policy
