Overall Degree Completion 40% – Applies to all institutions

- Represents the change in the number of degrees conferred over a three year period rolling average (average of FY 2010 – 2012 versus average of FY 2013 – 2015)
- Residency status is determined based on the fiscal year of degree conferment
- Applies to 18-29 credit hour certificates, one year certificates, and associate degrees conferred at two-year institutions
 - Bachelor's degrees are also included for Vincennes University
- Applies to bachelor's, master's, and doctoral degrees conferred at four-year institutions
 - Purdue Polytechnic Statewide Technology degrees are excluded for Purdue West Lafayette
 - Degrees from the IU School of Medicine and IU School of Dentistry are excluded for IUPUI

On-time Graduation Rate 30% – Applies to all institutions

- Represents the change in the on-time graduation rate over a three year period rolling average multiplied by the average number of first-time, full-time entry students in the latest three year period: (average FY 2010-2012 rate vs average FY 2013-2015 rate | multiplied by average number of first-time, full-time entry students FY 2013-2015)
- Residency and full-time statuses are determined based on the fall semester that the student entered as a first-time student. To be considered full-time, a student must be enrolled in 12 or more credits as of the institution census date.
- For two-year institutions, the metric includes students who initially sought an associate degree in the fall semester that they entered as a first-time student. Initial bachelor's degree seekers are also included for Vincennes University.
- For four-year institutions, the metric includes students who initially sought a bachelor's degree in the fall semester that they entered as a first-time student.
- To be considered as receiving a degree on-time, the student must (1) complete a degree at the same level or higher that they initially sought, (2) complete the degree within the same institutional system they were initially enrolled, and (3) complete the degree in the on-time timeframe based on initial degree level sought (within 2 years for initial associate degree seekers and within 4 years for initial bachelor's degree seekers).

At-Risk Student Degree Completion 20% – Applies to all institutions

- Represents the change in the number of degrees conferred to Pell grant recipients over a three year period rolling average (average of FY 2010 – 2012 versus average of FY 2013 – 2015)
- Residency and Pell grant statuses are determined based on the fiscal year of degree conferment
- Applies to 18-29 credit hour certificates, one year certificates, and associate degrees conferred at two-year institutions
 - Bachelor's degrees are also included for Vincennes University
- Applies to bachelor's degrees conferred at four-year institutions
 - Purdue Polytechnic Statewide Technology degrees are excluded for Purdue West Lafayette
 - Degrees from the IU School of Medicine and IU School of Dentistry are excluded for IUPUI

<u>High Impact Degree Completion 8% – Applies to Carnegie ranked high/very high research</u> <u>institutions: IUB, IUPUI, PUWL, and BSU)</u>

- Represents the change in the number of degrees conferred in "high impact" programs over a three year period rolling average (average of FY 2010 – 2012 versus average of FY 2013 – 2015)
- Residency status is determined based on the fiscal year of degree conferment
- High impact programs are programs that are granted in "high impact" fields according various national definitions (Complete College America, National Science Foundation, etc.)
- Applies to bachelor's, master's, and doctoral degrees conferred
 - Purdue Polytechnic Statewide Technology degrees are excluded for Purdue West Lafayette
 - Degrees from the IU School of Medicine and IU School of Dentistry are excluded for IUPUI

Student Persistence Incentive 1% – Applies to all non-research institutions

- Represents the change in the headcount of students meeting various credit hour threshold benchmarks over a three year period rolling average (average of FY 2010 – 2012 versus average of FY 2013 – 2015)
- Residency status is determined based on the fiscal year that the student meets the credit hour threshold
- Students are only included if they meet the credit hour threshold in a semester in which they are considered to be a degree-seeking undergraduate student
- Accepted credit hours that a student earns prior to entering the institution (dual credit, AP credit, transfer credit, etc.) are accounted for in the metric
- For two-year institutions, the metric includes students who successfully complete 15, 30, and 45 credit hours

• For four-year institutions, the metric includes students who successfully complete 30 and 60 credit hours

Remediation Success Rate 1% – Applies to two-year institutions

- Represents the change in the gateway course completion rate over a three year period rolling average multiplied by the average number of remedial students in the latest three year period (average FY 2010-2012 rate vs average FY 2013-2015 rate | multiplied by average number of remedial students FY 2013-2015)
- Residency status is determined based on the semester that the student entered as a first-time student
- Remediation status is determined based on remedial coursework attempted in the first year, and successful gateway course completion status is determined based on gateway coursework completed through the second year
- Applies to remedial and gateway courses in math and English
- Applies to students who attempt and complete the remedial and gateway college level coursework at the same institution.
- The metric includes three categories: math only, English only, and math and English. Students are included in only one category based on the subject(s) attempted.
