Introduction

This document outlines the rubric that will be used to review and approve a new administrator recertification course. The Office of the Idaho State Board of Education is responsible for this process. The new course syllabus and outline are emailed to the Office of the Idaho State Board of Education for review.

Upon conclusion of this course review, an approval determination of "Approved" or "Not Approved" will be made. The final approval determination will be communicated via electronic mail. New courses that do not meet all the requirements indicated in the rubric may be resubmitted at a later date after all corrections have been completed. All administrator recertification courses are transcripted through one of Idaho's higher education institutions.
